**OFFER BY AMERICAN CONSORTIUM FOR SETTING UP FERTILISER PLANTS**

•110. SHRI N. SRI RAMA REDDY: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state whether it is a fact that an American consortium has offered to set up five giant fertilizer plants in India?

THE MINISTER OF STATE IN THE THE MINISTRY OF PETROLEUM AND CHEMICALS (SHRI O. V. ALAGESAN): Yes, Sir; on behalf of an American Consortium an American firm has submitted a proposal for production and distribution of fertilisers to the extent of 1 million tonnes of nitrogen, by the end of the Fourth Plan period. The firm has been allowed to undertake a feasibility study to be completed by the end of December, 1964.
