REHABILITATION OF NEW MIGRANTS IN MADHYA PRADESH

THE MINISTER OF REHABILITA-TION (SHRI MAHAVIR TYAGI): (a) and (b) No, Sir. The Madhya Pradesh Government had offered to resettle 25,000 new migrant families (20,000 agriculturist and 5,000 non-agriculturist) in that State. There has been no change in this offer. Necessary funds for the implementation of the rehabilitation schemes are being provided by the Centre.

SETTLEMENT OF MIGRANTS IN BASTAR

- 133. THAKUR BHANU PRATAP SINGH: Will the Minister of REHABI-LITATION be pleased to state:
- (a) whether it is a fact that a large number of camps for new migrants are lying vacant in the Bastar region of Dandakaranya;
  - (b) if so, the reasons therefor;

- (d) if the answer to part (c) above be in the affirmative, what are the main grievances of the Adivasis?

THE MINISTER OF REHABILITATION (SHRI MAHAVIR TYAGI): (a) and (b) On account of difficulty of movement in the monsoon a few camps could not be filled to capacity.

- (c) No such cases have come to the knowledge of the Government.
  - (d) Does not arise.

THE MINISTER OF REHABILITA-TION (SHIR MAHAVIR TYAGI): (a) and (b) Apart from a large scale cattle breeding larm, a dairy farm and a poultry farm which are under the consideration of Dandakaranya Development Authority, a proposal for the setting up of 10 medium and major industries. as detailed below, for providing employment to 7,025 persons was received from the Government of Madhya Pradesh, which included:—
