### STATEMENT

- (a) Premises of 61 licensed wholesale and retail foodgrain dealers and dealers of essential commodities were raided by the police in collaboration with the Civil Supplies Department, Delhi and 81 persons were arrested. Out of the 61 cases, one case has been completed and has ended in conviction. The punishment awarded was imprisonment till the rising of the court, a fine of Rs. 2501and confiscation of 13 bags of wheat involved.

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION (SHRI BHAKT DARSHAN): (a) No formal report has so far been received; but the Government are aware of the performance of the Indian Olympic contingent at Tokyo.

- (b) Government's reaction is as under:
  - Hockey.—The Indian hockey team has done well in winning the Gold Medal and reestablishing India's supremacy in hockey.
  - (2) Athletics, wrestling and weightlifting.—The performance was not altogether unsatisfactory.
  - (3) *Shooting*.—The performance was below our expectations.
