CONCENTRATION OF PAK FORCES ALONG CEASE-FIRE LINE

SHRI R. S. KKANDEKAR:

Will the Minister of DEFENCE be pleased to state-

(a) whether it is a fact that Pakistani troops have been concentrating along the cease-fire line in Kashmir during the months of November and December, 1964;

(b) if so, whether it is a fact Pakistani troops have violated the cease-fire line many times during this period; and

(c) what steps are being taken to check such frequent violations?

THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN) : (a) There has been

a gradual movement forward of the Pakistan/Pakistan-occupied-Kashmir troops along the Cease-fire line during November and December 1964. However, no fresh induction of troops in the Pakistan-occupied-Kashmir area has been reported.

(b) Yes, Sir.

(c) Our Security Forces patrol the Cease-fire line to detect and prevent intrusions. In the case of firing by

Pakistan/Pakistan-occupied-Kashmir troops, our Security Forces return the fire whenever necessary. Besides, all Cease-fire violations are brought to the notice of the U.N. Military Observers.

EMPLOYEES OF DIBANG VALLEY IN LOHIT FRONTIER DIVISION

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether it is a fact that Government have received a memorandum from the lower grade employees of Dibang Valley in Lohit Frontier Division of N.E.F.A. regarding their living conditions; and

(b) if so, what steps Government have taken to ameliorate their grievances?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI N. MENON): (a) Yes.

(b) The grievance of the employees was that their salaries were not being disbursed regularly. Setting up of a separate Treasury for the Dibang Valley has been sanctioned and it is expected to have started functioning already. Besides this, the Administration are trying to overcome the delays in making regular payments to staff resulting from bad communications, difficulties of transport, and difficulties of providing cash escorts. The Assistant Political Officer, Dibang
