to Questions

PASSPORT TO SHEIKH ABDULLAH

Will the Minister of EXTERNAL AFFAIRS be pleased to refer to the answer given to supplementary questions on Starred Question No. 152 in the Rajya Sabha on the 24th November, 1964 and state:

- (a) whether Sheikh Abdullah has since applied for a passport to go abroad early next year; and
- (b) if so, to which countries and for what purpose he is going abroad?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI N. MENON): (a) and (b) Sheikh Abdullah has applied for renewal of his passport which was issued to him on 19th May, 1964, and which was valid up to 18th August, 1964. He has applied *tat* endorsement for countries of the Middle East, Europe (including Turkey) and U.K.

SHRI SANKAR PRATAP SINGH DEV: May I know, Sir, if it is a fact that he is going to settle down in Europe.

SHRIMATI LAKSHMI N. MENON: I do not know

SHRIMATI LAKSHMI N. MENON: The question relates to the issue of a passport to Sheikh Abdullah. The new application has been received in which he has stated that he wants to go to Haj and also visit hi_s sons in England.

SHRI A. B. VAJPAYEE; What about the latter part off my question?

SHRIMATI LAKSHMI N. MENON: That does not relate to the question.

Shri A. B. VAJPAYEE; It does. W>e know of cases in which passports have been refused on the ground that the Government did not think that the person who is going abroad will not carry *on* objectionable activities. Sir, we all know what Sheikh Abdullah stands for. We all know about his views. May I know, Sir, whether the Government have taken any assurance from Sheikh Abdullah that he will not carry on anti-India propaganda while abroad?

SHRIMATI LAKSHMI N. MENON: He applied for the passport. The mal ter is under consideration.

SHRI A. B. VAJPAYEE: Are you satisfied with this reply, Sir.

MR. CHAIRMAN: You cannot ask for an assurance.

SHRIMATI LAKSHMI N. MENON: No.

SHRI A. B. VAJPAYEE: He has got the passport. He has asked for | endorsement.

Shrimati Lakshmi N. Menoin: The passport wa_s valid only up to the 18th August, 1964. Now he has applied for a fresh passport.

SHRI A. B. VAJPAYEE* In reply, to *a* question the hon. Foreign Minister replied in the other House that Sheikh Abdullah ha_s reserved five seats in a particular ship going to Haj. Are we to understand that Sheikh AbduUah ha_s made the rservation without being assured by he Government that it will give a passpor..

SHRIMATI LAKSHMI N. MEN<f)N: That is quite possible. He might have reserved in advance

SHRI A. D. MANI: May I ask the Minister what reasons Sheikh Abdullah has given for his proposed toijtr to Europe? I can understand Haj. And, further, may I know whether he has asked for any special foreign I exchange for this?

SHRIMATI LAKSHMI N. MEljfON: I have already stated the reason given in the passport application. First is Haj pilgrimage and the second is to visit his sons in London.

SHRI A. D. MANI: Why?

SHRIMATI LAKSHMI N. ME^ON: Because his sons are in Londoi|i

MR. CHAIRMAN: Everybody will get a chance up to a limit.

SHRI ARJUN ARORA: May 1 know, Sir. if the normal procedure adepted for the Haj pilgrims has been adopted in the case of Sheikh Abdullah, or has he baen given a special treatment? The normal procedure is that intending Haj pilgrims apply, and as there are ^a large number of applicants, lot-Leries are drawn, and only in those cases where the applicants draw a lot in their favour they are allowed io go for Haj.

SHRIMATI LAKSHMI N. MENON: Sir, Sheikh Abdullah has approached the Port Haj Committee, Bombay, through the trading agent of the Government of Jammu and Kashmir for the reservation of five seats. Kashmir has got a quota of pilgrims and he will^be included in that quota.

SHRI P. N. SAPRU; May I know, Sir, if it is a fact that we are a democratic State and that it will be contrary to the principles of a democratic State to deny to a citizen of the country the right to visit a place of pilgrimage even on political grounds?

MR. CHAIRMAN: It need not be replied.

SHRI SYED AHMAD: Sir, in view of the question put by Mr. Vajpayee I want the Minister for External Affairs to make it clear that a passport in the sense in which an international Passport is issued is not generally issued to pilgrims going on Haj and that only Haj permits are issued and not passports at all

SHRIMATI LAKSHMI N. MENON: I have stated that he is not only going to Haj but he is also visiting other countries including the United Kingdom.

Shri OM MEHTA: May I know whether it is not a fact that in a recent statement Sheikh Abdullah has said that he would be visiting Middle East countries and Western countries where he would canvass for his stand against Kashmir's accession to India? He has made anti-Indian statement at the Sopur Convention and he said that he would canvass for that soeech when he visits foreign countries.

MR. CHAIRMAN: You want to know whelher he has said that in his application?

SHRIMATI LAKSHMI N. MENON: I have already said what he said in the application. All these things will be taken in.o consideration before a passport is given.

SHRI ABID /T: In view o'f the undesirable and anti-national activities of Sheikh Abdullah, will the Government take this opportunity, as he ha₃ submilted his passport for renewal, to impound it?

SHRIMATI LAKSHMI N. MENON: It is a suggestion for action.

SARDAR SW ARAN SINGH: It is not our intention to impound the passport.

SHRIMATI LAKSHMI N. MENON: The Government issues passports to visit outside countries without taking into consideration all these factors. If they are satisfied that the reasons given in the application are satisfactory, then passports are issued and many Members to whom passports have been issued have gone abroad and have vilified the Government and made anti-Indian speeches but we do not take those into consideration at all because Opposition Members have gone out of this country and have made violent propaganda against us, bringing discredit to the Government.

Smn ARJUN ARORA: Sham*.

SHRIMATI LAKSHMI N. MENON: Why not the Members then stand up and say that the passports should not be given?

THE DEPUTY MINISTER IN THI MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH); (a) and (b) It has been decided to permit 17,500 persons to proceed on Haj pilgrimage during 1965. About 32,000 application? are estimated to have been received by the Mogul Line Limited, and some representations were received for increase in the quota, but it was not possible to agree owing to the difficult foreign exchange posi tion.

SHRI ABID ALI: What was the number of persons who could not go last year because of this restriction *nd is it not a fact that a large number has been added to the present number of applications and bow Gov-
