THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI N. MENON): (a) Yes, Sir.

(b) The Indian Aid Mission administers the economic and technical aid which India is giving to Nepal under the Technical Asistance S-heme of the Colombo Plan. The Mission coordinates work in India-aided projects in fields of Nepal's economic diverse advancement. Members of the Aid Mission act as Advisers to the departments of His Majesty's Government of Nepal responsible for the construction of India-Aided development projects in different fields, such as communications, Irrigation, Water Supply. Power, Horticulture, Veterinary, Industrial Development, Geological Survey, Education, Archaeology and Technical Assistance etc. With the agreement of His Majesty's Government, the Mission is a'so responsible directly for the implementation of certain projects, such a- the Kalh-mandu Water Supply Scheme.
