THE MINISTER OF TRANSPORT (SHRI RAJ BAHADUR); (a) and (b) Coastal ships have already been carrying coal for quite a long time. The quantity of coal thus moved was about

1 million tons per annum till May 1961 when a revised target of 2 million tons per year was fixed due to the shortage of rail capacity.

THE MINISTER OF CIVIL AVIATION (SHRI N. KANUNGO): (a) No, Sir. Certain procedural arrangements have been agreed to on 26th October,

1964 for implementing the India-United States of America Air Services Agreement dated the 3rd February, 1956.

(b) Under the new arrangements agreed to, the United States Airlines are permitted to operate to or through any of the three points in India *viz*. Bombay, Delhi and Calcutta as long as n'o more than one such point is served on any one flight.

Subsequently, in view of the high prices of gram, barley and peas, the Government of Uttar Pradesh desired that the entire quantity of 50,000 tonnes might be supplied in the form of wheat. Arrangements could, however,, be made for the allotment of only 37,000 tonnes of wheat as indicate¹"! above. Government of Punjab was unable to spare a larger quantity.

- (ii) The Government of Gujarat require-2080 tonnes of Gram Seeds, The State Government was advised to contact the State Government of Rajasthan and Punjab direct in the matter. The information about quantities actually procured by Gujarat Government from these States is not available.
- (b) The seeds allotted to the above mentioned States were not procured by the Government of India. The concerned State Governments were however advised to depute a team of their Technical Officers to Punjab to-select varieties of seeds fit for sowings in their respective States. These Officers conducted inspection 'of consignments before despatch.
