(क) क्या यह सच है कि पश्चिमी बंगाल-पूर्वी पाकिस्तान सीमा पर स्थित स्वरूपनगर थाने के हकीमपुर गांव में तस्करी व्यापारियों का केन्द्र है; और

(ख) यदि हां तो इस बारे में सरकार ने क्या कार्यवाही की है ?

#### SMUGGLING ON THE EAST PAKISTAN BORDER

•756. SHRI G. K. KAPOOR: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that village Hakeempur under the jurisdiction of Swarup Nagar Police Station and situated on the West Bengal—East Pakistan border is a centre for smugglers; and

(b) if so, what action has been taken by Government in this connection?
