*775. THAKUR BHANU PRATAP SINGH: Will the Minister of HEALTH be pleased to state:

(a) whether it is a fact that the students getting Central scholarships in Gandhi Medical College, Bhopal, have gone on strike; and

(b) if so, the reasons therefor and the steps taken to avert the same?

THE MINISTER OF HALTH (Dr. SUSHILA NAYAR): (a) and (b) Certain Gandhi students studying at the Medical College, Bhopal, and receiving scholarships from the Central Government absented themselves on one or, more dates on the 27th November, and 5th and 7th December, 1964 apparently in sympathy with the demands of the internees and housemen in medical colleges in Delhi and Maharashtra. The strike has since been called off through efforts made at different levels.
