- (c) what steps are proposed to be taken by Government to achieve the target of production?]

उद्योग तथा संभरण मंत्रालय में भारी इंजी-नियरी तथा उद्योग के मंत्री (भी टी० एम० सिंह): (क) ग्रीर (ख) हैवी इलेक्ट्रिकल्स प्लाट भोपाल ने १९६३-६४ में ४५० लाख रुपों के मल्य का बेचने योग्य माल तैयार किया जबकि १९६३ के लिये मलाहकारों का मनमान केवल ४०४ : = १ लाख रुपये का था जैसा कि उनकी विस्तृत परियोजना रिपोर्ट में दिया हमा है। निर्माण संबंधी संशोधित एवं विस्तारित कार्यक्रम को देखते हए प्लांट के भ्रधिकारियों ने १९६३–६४ के लिये ग्रपना लक्ष्य ५३० लाख रुपये का निश्चित किया था जो प्राप्त नहीं हमा। १९६४--६५ मे नवम्बर के ग्रन्त तक २७० लाख रुपये के मस्य का बेचने योग्य माल तैयार किया गया जब कि इसी भवधि के लिये प्लांट का लक्ष्य ४०३ लाखा रुपये का रखा गयाथा। इस कमी का कारण कम उत्पादकता श्रीर मजदुरों के झगड़े थे।

N. and (b) During 1963-64, the Electricals Plant, Bhopal achieved saleable output valued at Rs. 450 lakh against the Consultants' estimate o Rs. 404.81 lakhs for 1963 as laid down in their Detailed Project Report. Ir view of the modified and expanded manufacturing programme, however the plant authorities had set their own target for 1963-64 at Rs. 530 which was not reached. During 1964 65 up to end of November the saleable butput is Rs. 270 lakhs against Plant's own target of Rs. 503 lakhs for the same period. The reasons for the shortfall are low productivity labour trouble.

(e) Introduction of an incentive scheme to step up production is under active consideration. Labour problems are also being tackled as far as possible on a long-term basis.l

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRT SHAM NATH): The recommendation made by the Coal Controller to revise the working hours for the loading of coal from 4 A.M. to 8 P.M. in place of 6 A.M. to 10 P.M. has been accepted by Government, and it is proposed to implement this recommendation from 1st February, 1965.
