

(c) About one lakh square feet of office accommodation and 1,400 residential units are under construction. The office and residential space that will be vacated in Delhi will only be known after the movement has taken place.

#### COMPANY SECRETARYSHIP EXAMINATIONS

201. SHRI M. P. BHARGAVA: Will the Minister of FINANCE be pleased to refer to the reply given to the question No. 361 on the 23rd September, 1964 in the Rajya Sabha and state:

(a) whether Company Secretaryship examinations are held annually or periodically by the Company Law Board;

(b) what is the composition of the Advisory Board which has been set up to assist the Company Law Board; and

(c) whether this examination is affiliated to any other body holding similar examination abroad?

1. One Official Chairman nominated by the Minister;
2. Three Members representing other Departments interested in the subject, and Government Undertakings;
3. Four members from the Profession connected with the management of companies nominated by the Government.
