private telecom operators to provide phone connections in rural areas. If so, what are the details?

SHRI DAYANIDHI MARAN: Sir, the hon Member wanted to know whether any funds are being created for telecom infrastructure for rural areas. I have mentioned it very clearly that there is a proposal in the DoT to use the USO fund so as to support the passive infrastructure to enable mobile connection in the rural areas. Already, under the USO fund, basic services are being provided in those villages, which are not profitable

SHRI C. PERUMAL: Sir, I would like to know whether BSNL has achieved the target for providing telephones in rural areas and if not, then what are the reasons? I have one more doubt. I would like to know whether Government is aware that the service is very poor in BSNL end MTNL mobile phones, considering that the person has to try many times before getting connections from one phone to another phone. If so, what action has been taken upon it?

SHRI DAYANIDHI MARAN: Sir, I have already answered the first part.

Autonomous Colleges

*315. PROF. P.J. KURIAN Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government propose to give permission for more autonomous colleges;

(b) if so, the details thereof and if not, the reasons therefor; and

(c) the number of such autonomous colleges in the State of Kerala?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD.ALI ASH RAF FATMI): (a) to (c) A Statement is laid on the Table of the Sabha.

Statement

(a) and (b) The status of autonomous colleges is granted by the affiliating

university with the approval of the appropriate government on the recommendation of the University Grants Commission (UGC). The Commission recommends grant of autonomous status to colleges which satisfy the criteria laid down under its guidelines. Therefore, grant of autonomous status to more colleges would depend on receipt of proposals in UGC from colleges satisfying the prescribed criteria.

(c) Presently, there is no autonomous college in the State of Kerala.

PROF. P. J. KURIAN: Thank you, Sir. The ballot is rarely in my favour but due to the absentee Members I am getting this question. Thank you very much Sir. Sir, I would like to know what is the policy of the Government with regard to autonomous colleges and whether the Government is doing something about it. But, Sir, the answer is disappointing. The answer says that the UGC receives applications and they decide on the autonomous colleges. Sir, all education experts agree that more autonomous colleges will help in the improving education, and, yet, the answer says as if the Government has no responsibility over this. I would like to know from the hon. Minister whether Government has a policy on this? Is the policy in favour of increasing the number of autonomous colleges? What steps the Government is taking to increase the number of autonomous colleges?

श्री मोहम्मद अली अशरफ फातमी : सर, माननीय सदस्य ने किसी कॉलेज के ऑटोनोमस होने की प्रक्रिया संबंधी जो जानकारी चाही है, उसके बारे में मैं उहें बताना चाहता हूं कि इसके लिए रूल्स-रेगुलेशंस बिल्कुल स्पष्ट हैं कि कोई भी कॉलेज यदि ऑटोनोमस होना चाहता है तो या तो वह युनिवर्सिटी में ऐप्लाई कर सकता है या फिर वह यू.जी.सी. डायरेक्ट ऐप्लाई भी कर सकता है , लेकिन उसके लिए जब तक युनिवर्सिटी और स्टेट गवर्नमेंट की रजामंदी न हो और वह कॉलेज इस लायक न हो कि उसे ऑटोनोमस माना जाए, तब तक यह मुमकिन नहीं है । जब कोई कॉलेज ऐप्लाई करता है, तो उसके लिए एक एक्सपर्ट कमिटी बनती हैं जो सारी बातों को देखती है – कॉलेज का स्टेंडर्ड किस तरह का है, उसके बिल्डिंग्स कितनी है, उसकी लैब कैसी है, उसकी लाइब्रेरी कैसी है, आदि, आदि । एक्सपर्ट कमिटी इन सारी चीजों को देखकर, उस कॉलेज के बारे में सारी जानकारी लेकर अपनी रिपोर्ट तैयार करती हैं, अगर वह रिपोर्ट दुरूस्त है और उसके लिए युनिवर्सिटी और स्टेट गवर्नमेंट एग्री हैं, तो उसे ऑटोनोमस माना जा सकता है। रिपोर्ट दुरूस्त होने के साथ-साथ युनिवर्सिटी और स्टेट गवर्नमेंट का भी एग्री होना बहुत जरूरी है।
