THE DEPUTY MINISTER IN THE DEPARTMENT COMMUNICA- \mathbf{OF} TIONS (SHRI B. BHAGAVATI): (a) and (b) The existing Central Circle conwhole of Madhya sists of the Pradesh and Vidharba Region of Maharashtra It has been decided to create a Circle with Headquarters at Bhopal comprising only the Madha Pradesh area but on account of nonavailability of office and residential accommodation at Bhopal it has not been possible to constitute the Circle. Land has however since been acquir-Projects of ed at Bhopal and the buildings have been budgetted for the current year. The Madhya Pradesh Circle will be shifted to Bhopal as as accommodation has been soon constructed.

SENIORITY OF MEMBERS OF POSTS AND TELEGRAPHS BOARD

- 44. SHRI M. P. BHARGAVA: Will the Minister of COMMUNICATIONS be pleased to refer to the answer given to Starred Question No. 179 in the Rajya Sabha on the 30th April, 1964 and state:
- (a) whether it is a fact that some attempts were made to change the seniority of the members of the Posts and Telegraphs Board; and
- (b) if so, whether Government received any protests against such attempts?

THE DEPUTY MINISTER IN THE DEPARTMENT OF COMMUNICA-B. BHAGAVATI): (a) TIONS (SHRI and (b) Representations were received from two members of the Posts and Telegraphs Board against superseding their seniority. There was also a representation by an officer claiming appointment to a post of Member, Posts and Telegraphs Board, on the basis of his seniority. The views of the Union Public Service Commission have been ascertained and the matter is under examination.

HALDIA PORTS

- (a) whether the decision on India's request for a loan from the World Bank for the development of the Haldia port has been delayed;

- (d) whether in this connection Government are trying any alternative source for loans?

The MINISTER or TRANSPORT * (SHRI RAJ BAHADUR): (a) No. Sir A request for a loan from the World Bank for the construction of the Haldia Port was made in December, 1963; the World Bank has asked for ancillary information of a technical. and economic nature which are under compilation. Further progress negotiations will depend upon the · evaluation of the project, together with this ancillary information, the World Bank.

- 46. SHRI M. M. DHARIA: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government are awareof the popular demand and the need for a railway station at Satara City; and
