THE MINISTER OF STEEL, MINES AND HEAVY **ENGINEERING** (Shri SUBRAMANIAM): (a) The difficulty has arisen only in Orissa. Pending a decision on the dispute between the State Government and some mine-owners regarding the manner of assessing royalty, the following relief has been given by the Central Government.

In regard to the royalty claimed by the State Government for the period ending December 1960, Government of India has granted the facility of payment of the dues claimed, in instalments. The State Government were also restrained from dispossessing the lessees by issue of stay orders.

Regarding the royalty claimed by the State Government for the period December, 1960 to December, 1962, the Central Government have been assured that the State Government are themselves considering grant of facility to pay in suitable instalments.

(b) As mentioned by m_e earlier in reply to Short Notice Question No. 25, dated the 6th May, 1964, two officers are being appointed to ensure speedy disposal of revision applications.. They are expected to join duty shortly.
