(a) whether it is fact that Mr. John B. Gates, Vice-Chairman of the .Inter national Hotels Corporation, at a press conference in New Delhi admitted that tourism wa<sub>s</sub> a multi-pronged industry and following reasons were responsi ble for not attracting large number of tourists in this country;

(b) The Government, being aware of a few of these difficulties, appointed in March, 1963 an *ad hoc* committee to enquire and suggest ways and means of expanding tourist traffic. The Report of the Committee was submitted *on* the 23rd August, 1963 and the principal recommendations have been accepted by the Government. Steps are being taken by the Government to Implement the important recommendations of that committee.
