SHRI A. M. THOMAS: When we find it difficult even to supply the existing card-holders, it would be difficult to issue new cards. But all the same having regard to the trend of supply now, it is increasing now after the steps that have been taken. So we may perhaps be in a position to issue new cards.

SHRI M. P. BHARGAVA: Sir, may I make this submission? This problem is agitating almost every Member of the House. I have given notice of a no-dayyet-named motion. I would request you to allow discussion on this subject.

SHRI A. B. VAJPAYEE: We join %ith him in this.

SHRI ARJUN ARORA: I support the demand. I request the Minister to give this House an opportunity to discuss it.

MR. CHAIRMAN; I do not give any assurance at present. I will look into the matter. In the meantime Shri Kureel has to put a question.

CENTRAL TEAMS ON AGRICULTURAL **PRODUCTION**

- •52. SHRI A. D. MANI: Will the Minister of FOOD AND AGRICULTURE be pleased to state:
- (a) whether any joint Central teams on agricultural production are proposed to be sent to the States during this summer to look into the production programmes of the States concerned; and
- (b) if so, what is the composition of the teams proposed to be sent and what specific purpose they would have in view?

THE MINISTER OF STATE IN THB MINISTRY or FOOD AND AGRI-CULTURE (SHRI RAM SUBHAO SINGH): (a) Yes Sir. The Joint Central Teams on Agricultural Production started visiting the States from 11th May and are likely to complete their visits by about the middle of June.

administrative and technical officers from the Planning Commission and the Ministries of Food and Agriculture, Community Development and Cooperation and Irrigation and Power. Wherever feasible, Central Ministers | Members of Planning Commission would also join the Teams. The purpose of the visits of the Team is to secure close collaboration between the Central and State Governments in formulation of agricultural production programmes.

SHRI A. D. MANI: According to my information similar teams visited the States in April-June of last year. I should like to know whitfh States they visited and what was the result of their investigation. Was there an increase in production?

SHRI RAM SUBHAG SINGH: Last year, similar teams had visited all the States of our country, and on the basis of their report a provision of about Rs. 194 crores was made for additional schemes. and those schemes are under implementation at present Some have already been implemented.

SHRI A. D. MANI: Is it the objective of these teams to recommend inceas-ed allocation for agricultural production in the States or is it the objective that they should examine and inspect the work which is being done in tha States in respect of agricultural production?

SHRI RAM SUBHAG SINGH: The intention is to examine and inspect, not in the sense of inspection because the State Governments according to our Constitution have to look after agriculture, but the idea is to secure close collaboration" between the Central and State Governments in the formulation and effective implementation of agricultural programmes. Last year also similar work was done. But over and above this programme the teams also recommended some additional schemes some of which were implemented and some are being implemented at present.

(b) The Central Teams comprise *enior SHRIMATI SHAKUNTALA PARANA ministrative and technical officers PYE: May I know in how many States the Government had found that there was an increase in agricultural production on the allocation that was just mentioned?.! would like to know whether it is a spending scheme or • production scheme.

> Shri RAM SUBHAG SINGH:: Because the production scheme is based on the spending scheme, so the intention is to effect increased production, and I would require notice for giving the exact figure; but there are a good number of States where agricultural production has improved, particularly Madras, Punjab, etc.

SHRI NIREN GHOSH; May I know whether the projects which tha Finance Minister announced—soma package schemes of intensive agriculture—have also come under tha investigation of these teams, and instead of talking and setting up teams, when will Government actually see that production is increased on an all-India scale?

SHRI RAM SUBHAG SINGH; What was announced in the Budget Speech is also included because these teama are supposed to visit at least one intensive agriculture district other than the usual package districts, and the idea is to effect improvement. I do not think that what the hon. Member said is correct; he said in a somewhat easier way, "What is the idea"? The idea is to effect improv-ment and it is being done.

SHRI A. D. MANI: Will Government place the Reports of these teams on the Table of the House?

SHRI RAM SUBHAG SINGH: Last year, in a booklet form, in reply to a question, it was placed in the Lok Sabha. And though it is not so necessary, there will not be much difficulty to do that. We will do it.

SHRI N. SRI RAMA REDDY: I would like to know the specific purpose which these Agricultural

Teams are being sent. Does it arise on account of the fact that there are certain gaps in the knowledge and techniques that are available at the State level which are supposed to be made good or is it on account of any 'superior technique that is available with the Central Ministry that these teams are going and educating the agricultural staff at the State level?

SHRI RAM SUBHAG SINGH.- I do not think that we should feel obsessed with any superiority or inferiority complex. Actually, the people who are on the field are not possessed of such knowledge as the technical people have. So, there is need to coordinate the two, the field people as well as the technical staff. So, it is the case of Government apparatus at the district and village levete. At the State level as well as the Central level, there is some differenc between the standards of the two and therefore it is necessary that they should seek perfect coordination an* collaboration. But the superiority question I will not admit.

SHRI S. C. DEB; The hon. Minister was saying that these teams were going over the States to improve agricultural production. At places where much damage to crops is being done by floods or by some other causes, may T know whether the teams are considering any schemes to Krow alternative crops to have better production of agriculture?

SHRI RAM SUBHAG SINGH: That is also our intention, «nd I know the area the hon. Member comes from; it is an area where the flood destroys much of the crop. So, we are thinking that we should try to raise one crop before the onset of the flood, and this is one of the schemes that are included. Everywhere we are trying to distribute that type of seed. And T will request the Assam Government, we have already done that. But we will further activise this programme.

SHRI LOKANATH MISRA: May I know if it is not a fact that in spite

of the tremendous expenditure that we are incurring on agriculture our country's percentage of increased production is much less than that of countries which did not spend anything, and in view of that, is Government thinking of reorientating the entire pdlicy on agriculture?

SHRI RAM SUBHAG SINGH: Actually, the entire policy and the programme, they are all under constant review and change also and then, this new change has occurred, and the Agricultural Production Board is constantly examining this. Already we have had under the chairmanship of the Minister of Food and Agriculture so many meetings with regard to reviewing the policy. It was pointed out by the hon. Member that it is not meeting our require, ments. It is a fact that production has increased and our requirement has increased, not in that proportion but a little more but we are trying to struggle a little more.

SHRI BHUPESH GUPTA: What is that . .
