PROVISION OF FOOD FOR REFUGEES

*91. SHRI SURJIT SINGH ATWAL: Will the Minister of REHABILITATION be pleased to state whether it is a fact that refugees are not provided food at Sealdah Station or other places on entering Indian territory?

THE MINISTER OF REHABILITATION (SHRI MAHAVIR TYAGI): Migrants into West Bengal, who need relief and rehabilitation assistance, are received at the reception centres near the border at Banpur, Hasnabad and Petrapole. They are provided food at the reception centres and also at Howrah before they are sent by special trains to the transit centres near Raipur.

As regards Tripura, dry ration is given in deserving cases to the migrants on arrival in Tripura.

As regards Assam, migrants entering that State through transit camps on the border are provided with food and other necessaries.
