Association of India which is loyal to j KMT China; and

(c) if so, what action Government propose to take thereon?

THE PRIME MINISTER AND MINISTER OF **EXTERNAL AFFAIRS** (SHRI GHLZAPJ LAL NANDA): (a) As far as Stateless Chinese are concerned, technically it is not possible to differentiate between KMT Chinese and the Communist Chinese residents of India since they do not hold documents showing their political allegiance. The security of the country is the sole consideration which affects Government's policy in dealing with persons of Chinese origin.

- (b) A representation was received recently by the Government of India from the Overseas Chinese Association of India.
- (c) The various issues raised in this representation are under Government's active consideration.

VISA FACILITIES TO KMT CHINESE

- 110. SHRI SUNDER MANI PATEL: Will the PRIME MINISTER be pleased to $_{\rm s}$ tate:
- (a) what is the procedure for giving visa facilities to the tourist', holding KMT China passport, who want to visit India; and
- (b) whether Government have any arrangements to provide visas to the KMT Chinese who want to attend international conferences, etc., in India?

THE PRME MINISTER AND MINISTER OF EXTERNAL AFFAIRS (SHRI GULZARI LAL NANDA): (a) Visa facilities are not given to touruts holding 'KMT' China passports to visit India.

(b) Chinese (Formosan) nationals are allowed to come to India to participate in conferences, training courses etc., sponsored by the U- N. and its specialised agencies. Visas in such cases are granted on affidav'ts.

- (c) In his capacity as Chairman of the Planning Board of Orissa.
