THB DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) Yes, Sir, but this is confined 'only to regulations pertaining to parking.

## (b) The matter is receiving attention.

SHRI I. K. GUJRAL: May I know, Sir, if the Ministry of External Affairs sent out a circular to all the diplomatic missions in Delhi asking them to take special care of the rules of traffic in the town, and, if so, have the complaints of traffic violations in Delhi decreased after this circular letter or have they increased?

SHRI DINESH SINGH: Yes, Sir, the Ministry of External Affairs drew the attention of foreign missions in Delhi to this matter. I cannot say offhand if the violations have increased or decreased.

, SHRI C. D. PANDE: May I know whether this withdrawal of diplomatic immunity was only in respect of India, or was it in respect 'of all other missions in the States?

SHRI DINESH SINGH; It is not any withdrawal of diplomatic immunity. It is with respect to some parkings. Apparently there have been parking violations, violations of the U.S.A. parking laws. It is in respect of parking laws.

SHRI G. RAMACHANDRAN: Is there any information as to why this particular step was taken at this time in Washington?

SHRI DINESH SINGH: As 1 have mentioned, they must have come up •against a lot of parking violations.

TMTHE MINISTER OF DEFENCE PRO DUCTION IN THE MINISTRY OP DEFENCE (SHRI K. RAGHU RAMAIAH): (a) and (b) A proposal for the establishment of a factory first the manufacture of 3 Ton and 1 Ton vehicles is under consideration. A final decision on the site has not been taken.

SHRI K. RAGHU RAMAIAH: Sir. it is premature now to say anything of the kind, because we do not know where the factory will be set up, whether the factory is -going to be put up at all, and so all this will be considered only later.

SHRI FARIDUL HAQ ANSARI: May I know since when this question has been under consideration and when the 'final step is going to be taken in this respect?

SHRI K. RAGHU RAMAIAH: This is under consideration for quite some time.

SHRI FARIDUL HAQ ANSARI: Date?

SHRI K. RAGHU RAMAIAH: For quite some time, I cannot say offhand the date, but it is quite some time. It is not as if vehicle production is not going on. Vehicle production is going on. But the idea is to have a single factory located at one place where all these can be manufactured with a view to effecting economy as well as expansion. There are -s<Hrie implications of foreign exchange also find various Ministries are concerned with it and this matter is being pursued very actively.

SHRI A. D. MANI: What is the extimated capital investment for this factory if the proposal comes through?

SHRI K. RAGHU RAMAIAH: It would be premature even to say that, because what should be spent on it, whether there should! be such a factory, what quantum of production there should be, all these aspects are being examined and so it would be premature to say anything now.

SHRI R. S. KHANDEKAR: May I know if any assessment of the potential of the different factories in Madhya Pradesh for producing defence equipment has been made and, if so, what is the assessment?

SHRI K. RAGHU RAMAIAH: There was some time back a similar question asked and I think that was answered. In pursuance of an invitation of the Industries Minister of Madhya Pradesh I went there and subsequently the Director of Industries there was put in touch with the Director-General of Ordnance factories and some assessment was made and officers are looking into the matter to see in what way any capacity there can be utilised.
