770. SHRIMATI SARLA BHADAU-RIA: Will the Minister of RALWAYS be pleased to state the names of stations on each Railway, where private canteens are being run and the reasons therefor?]

RAM SUBHAG SINGH): Apparently, the member has in mind catering or vending establishments provided at railway stations and managed by contractors. Compilation of the information desired will involve considerable labour and time which will not be commensurate with the results likely to be achieved.

Excepting 94 stations at which arrangements for the sale of edibles are made departmentally, at other stations, about 2,400 in number, the arrangements are through contractors. it is not the intention to introduce departmental catering at all stations but to improve the quality of food and standard of service in all catering establishments run both departmentally as well as through contractors.]
