SHRI I. K. GUJRAL: May I ask the Minister that near the Safdarjang airport where the approach roads have already been completed when does the Railways propose to start the construction of underbridges?

SHRI SHAM NATH: I want notice for this, Madam.

MOTOR CARS (DISTRIBUTION AND SALE) CONTROL ORDER, 1959

SHRI R. P. N. SINHA: † *559. SHRI B. B. VARMA: SHRI C. D. PANDE:

Will the Minister of Industry and Supply be pleased to state whether the 2-year rule regarding the sale and transfer of cars is applicable to the vehicles purchased before the issue of these orders or it covers only cases arising after the issue of the said orders?

THE MINISTER OF HEAVY ENGI-NEERING IN THE MINISTRY OF INDUSTRY AND SUPPLY (SHRI T. N. SINGH): In accordance with clause (8) of the Motor Cars (Distribution and Sale) Control Order 1959, which came into force from the 1st May, 1959, the two-year restriction on the sale and transfer of new cars is applicable to all new vehicles purchased after the 1st May, 1957.

SHRIMATI C. AMMANNA FAJA: What is the rule at the present moment?

SHRI T. N. SINGH: The present rule stands.

SHRI C. D. PANDE: May I ask the hon. Minister the reasons for the deviation from the general practice? The general practice is that the newly made rules are applicable only to such cases where the cars are purchased on or after the date on which the new rules came into force. In this case is it right to give retrospective effect after the cars have been purchased before the new rules came into force?

SHRI T. N. SINGH: The idea was that the Order was promulgated in 1959 and it applied to cars purchased two years back, in the year 1957, because after the expiry of two years only a car could be sold.

SHRI C. D. PANDE: Suppose a car was purchased in 1962, before that amended Order was passed, what will be the position?

THE DEPUTY CHAIRMAN: The Order came into force on the 1st May, 1959.

SHRI BIREN ROY: Is it the position that cars which are purchased in 1961 can only be sold after four years?

SHRI T. N. SINGH: No no; two years.

SHRI N. SRI RAMA REDDY: This two-year rule is likely to cause some inconvenience. Will the hon. Minister think of reducing it to one year?

SHRI T. N. SINGH: Not in the near future.

SHRI I. K. GUJRAL: May I ask the hon. Minister, from his experience of the working of this Order and the long waiting lists, whether he has been convinced that at least now the time has come when the small car manufacturing project should be revived?

SHRI T. N. SINGH: That is a separate question and can be dealt with separately.

SHRI R. P. N. SINHA: Four years is much too long a period.

THE DEPUTY CHAIRMAN: Four years is too long a period, says Mr. Sinha.

SHRI T. N. SINGH: In view of the shortage today it is even felt that it is proper to extend the period to four years.

SERI BHUPESH GUPTA: Doe; the rule apply to Members of Parliament? And then what happens? Suppose, a'ter buying the car General Elections take place and he loses his seat can he sell it?

SHRI T. N. SINGH: I am sure Members of Parliament would like to follow the same rule which is applicable to others.

SHRI BHUPESH GUPTA: I want to know the position; it is 'suppose'.

SHRI T. N. SINGH: The rule applies equally to all.

NIGHT DUTY ALLOWANCE FOR COMMER-CIAL DEPARTMENT EMPLOYEES

*533. SHRI B. K. GAIKWAD: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that all railway employees are paid night duty allowance except the Commercial Department employees; and
 - (b) if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAM SUBHAG SINGH): (a) No. Sir.

(b) Does not arise.

SHRI D. THENGARI: Is it not a fact that these commercial clerks are not given night allowance?

SHRI RAM SUBHAG SINGH: I said 'No' because booking clerk; do get night allowance, and there are others who do not get that night allowance, and it is according to the duties night allowance the given. The issue was first referred to Justice Rajadhyaksha and he did not recommend that. Later on this matter was examined by Justice Jagannath Das and he did recommend that and so the whole thing was revised.

DEVELOPMENT OF JUTE INDUSTRY
