**REQUEST FOR GOVERNMENT STATEMENT ON IAC DISPUTE**

SHRI BHUPESH GUPTA (West Bengal): Sir, before we pass on to legislative business, I would like Government to make a statement with regard to the dispute between the IAC authorities and their employees. The situation has reached a stage where we find that services are being cancelled. I would like to know what steps the Government is taking in the matter in order to deal with the situation to the satisfaction of the IAC pilots so that the services could be resumed and the matter settled satisfactorily. It is a very, very important matter.

MR. CHAIRMAN: I do not know if the Government are inclined to do so, but I have not been able to pass on the notice to them.

THE PRIME MINISTER (SHRI LAL BAHADUR) : I can say that the matter is engaging the attention of the Ministry concerned. The Minister is personally taking direct interest in it. The Finance Minister has also been apprised of the progress because the Finance Minister is concerned. Certain payments are to be made. I can assure the House that if we find it necessary, we will certainly place a statement on the Table of the House.
