श्री भगवत नारायण भागवत : क्या
मैं यह जान सकता हूँ कि हायर सेकेंडरी

SHRI M. C. CHAGLA: There are three
higher secondary schools in the Islands, one
for girls, one for boys in Port Blair and one in
Car Nicobar. The output of these schools—
about 30 per year—does not at present justify
the opening of a college in the Islands.

IRREGULARITIES IN THE HINDUSTAN INSECTICIDES LTD., NEW DELHI

*561. SHRI A. D. MANI: Will the Minister
of PETROLEUM AND CHEMICALS be pleased to
state:

(a) whether it is a fact that some ten
Members of Parliament have brought to the
notice of Government serious irregularities in
the working of the Hindustan Insecticides
Limited, New Delhi; and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE
MINISTRY OF PETROLEUM AND
CHEMICALS (SHRI O. V. ALAGESAN): (a)
Yes, Madam.

(b) As the matter is still under examination it is not possible to furnish the details at this stage.

SHRI A. D. MANI: Madam, some of the allegations made by M.Ps. relate to the promotion of a number of men, which has undermined confidence. This is a matter of fact and the Minister should be in a position to say whether such promotions have been made in a haphazard manner in the factory.

SHRI O. V. ALAGESAN: Madam, the point that the hon. Member mentions is only one of the points which have been raised by the M.Ps. that visited this factory. They have raised other points also. All these points are under examination by the Board. I may also inform the House that subsequently the Committee on Public Undertakings, paid a visit to the same factory. They have also raised certain points. All these things will be enquired into and duly reported to Parliament.

SHEH FARIDUL HAQ ANSARI: Madam, may I know whether these promotions have been made according to some rules or there are no rules for making these promotions?

SHRI O. V. ALAGESAN: There are certain rules of course and these promotions take place under those rules. But the M.Ps. have pointed out that there are no clear-out rules and policies. That is one of the points that they have raised. So I said that these points along with others are under examination.

SHRI A. D. MANI: Madam, I am not satisfied with the Minister's reply in that the matter is under examination. There are certain questions on which information is required. For example, one of the allegations made is that in the Defence Colony for the Managing Director residential accommodation has been secured at Rs. 15,000 a year when he could have very well stayed somewhere in the factory compound. Is that a fact or not?

SHRI O. V. ALAGESAN: That is a fact, Madam. The hon. Member may go on raising one point after another, but we are awaiting the reaction of the management itself with regard to this. The Managing Director was living somewhere near or within the premises of the factory but later on it was found that it would be better to have the office elsewhere and so he moved on there. And the other things will be duly considered and reported.

SHRI G. M. MIR: I would like to know from the hon. Minister when these serious irregularities in the working of the Hindustan Insecticides Limited were brought to the notice of the Government by the Members of Parliament, and what is the reason for such a long delay in finding an answer for this question?

SHRI O. V. ALAGESAN: The hon. Member perhaps said that there has been delay. I said, Madam, that subsequently the Committee on Public Undertakings, also paid a visit to the factory. They have also made some remarks. We are awaiting their report.

SHRI G. M. MIR: When was it brought to the notice of the Government?

SHRI O. V. ALAGESAN: Madam, I do not have the point of time. We are aware that the hon. Members of Parliament paid a visit and they have submitted their report. We have got a copy of the report. We have asked the management to submit their explanation. They have placed it before their Board and further action is also being taken; it will be duly reported to the House.

SHRI V. M. CHORDIA: May I know how long it will take to have full consideration?

SHRI O. V. ALAGESAN: Madam, it should not take long.

THE DEPUTY CHAIRMAN; Not long. How long is not long? (J'i:er-ruption). Next question.

SENIORITY OF ASSISTANTS

*S62. SHRI V. M. CHORDIA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that the seniority of Assistants is not determined strictly from the date of confirmation in Grade IV and that Assistants directly recruited become senior to Assistants promoted from ranks and confirmed much earlier; and

(b) if so, whether Government propose to revise the existing rules regarding seniority?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI L. N. MISHRA) : (a) and (b). Seniority in the Assistants' Grade is fixed in accordance with the provisions of Rule 18, II read with the Fourth Schedule of the Central Secretariat Service Rules, 1962, a copy of which is laid on the Table of the House. [See Appendix XL IX, No. 58].

A direct recruit is eligible for confirmation on successful completion of his probation while a promotion can be confirmed from the date of vacancy or the date of his continuous officiation whichever is later.

There is no good ground for revising the rules.

श्री विमलकुमार मन्नालालजी चौरडिया : क्या श्रीमन्, इस बात की अनुमति नहीं करते कि जो आदमी पहले कनफर्म हो जाता है उससे जो आदमी यू० पी० एन० सी० से बाद में आकर नियुक्त होता है वह सीनियर हो जाता है ? तो यह जो गलती है बा फर्क है, इसको दूर करने में क्या कठिनाई है ?

श्री ललित नारायण मिश्र : यह गलत नहीं है। यह सही है क्योंकि जो यू० पी० एन० सी० के द्वारा डाइरेक्ट रेक्यूटमेंट से आते हैं वे पर्मानेंट बैकसीज़ पर आते हैं और जो डिपार्टमेंटल प्रोमोशन से आते हैं उनको जैसे जैसे बैकसीज़ हाती जाती है वैसे जगह मिलती जाती है। तो इसमें कोई गलत बात नहीं है।

श्री विमलकुमार मन्नालालजी चौरडिया : क्या यह बात सही नहीं है कि जो विभागीय कर्मचारी सन् १९५४ या १९५६ में किसी पद पर नियुक्त कर दिया गया और उसी समान पद पर पब्लिक सर्विस कमिशन की माफ़त कोई कर्मचारी सन् १९६१ में आया, तो अभी ऐसी व्यवस्था है कि जो कर्मचारी सन् १९६१ में आया वह सन् १९५६ से उसी पद पर नियुक्त कर्मचारी से सीनियर हो जाता है ? ऐसी स्थिति में इसको ठीक क्यों कहा जाता है ?

श्री ललित नारायण मिश्र : मैं एक बात बता दूँ कि कनफर्मेशन से सीनियरिटी और तरक्की में कोई रुकावट नहीं होती है। अगर पहले भी कोई कनफर्म हो जाता है तो उससे प्रोमोशन में किसी को कोई नुकसान नहीं होता है। जो सन् १९५४ और १९५६ की बात कही गई है, उसका मुझे पता नहीं है और उसकी सूचना चाहता हूँ।
