STATE TRADING IN FOODGRAINS

Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) whether in view of the deteriorating food situation, Government propose to make radical changes in Food Policy and would begin state trading in foodgrains shortly; and

(b) if so, what steps have been taken in this direction?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI C. SUBRAMANIAM): (a) and (b) Several measures have been taken to deal with the food situation. There is no proposal to introduce full-scale state trading under which the procurement of the entire marketable surplus of foodgrains in the country and its distribution will be taken over by Government. The Government, however, are purchasing from internal sources and importing from abroad large quantities of foodgrains and distributing through fair price shops etc. It is also proposed to set up a Foodgrains Trading Corporation to purchase and sell foodgrains on a commercial basis and to achieve a commanding position in the foodgrain trade.

CO-OPERATIVE FARMING

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI B. S. MURTHY): (a) and (b) The matter is under consideration.

DELAYS IN I.A.C. SERVICES

THE MINISTER OF CIVIL AVIATION (SHRI N. KANUNGO): (a) Yes, Sir.

(b) Delays are incidental to all operations but the abnormal delays to which the General Manager had made reference were in relation to Caravelle services.
