NEW AIR SERVICES

- »4. SHRI M. P. BHARGAVA: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether it is proposed to run new air services within India from 1st October, 1964;
 - (b) if so, what are the details thereof; and
- (c) whether there is any proposal under Government's consideration to discontinue some of the uneconomic-services being run at present?

THE MINISTER OF CIVIL AVIATION (SHRI N. KANUNGO^: (a) and (b) The Indian Airlines Corporation propose to operate through Bhopal again and link Bhubaneswar and Visakhapatnam with effect from "1st October, 1964. The Corporation also propose to provide additional service to Goa with Viscount Aircraft on 4 days a week.

(c) The Corporation have no proposal at present to discontinue any of the existing Air Services.

SHRI M. P. BHARGAVA: May I know, Sir, what the proposed new service between Visakhapatnam and the various cities of India

SHRI N. KANUNGO: The present arrangement is to provide air links, between Bhubaneswar and Visakhapatnam, that is, Calcutta, Bhubneswar and Visakhapatnam.

SHRI M. P. BHARGAVA: Will it be a daily service?

SHRI N. KANUNGO: It will be twice a week.

SHRI M. P. BHARGAVA: May I know, Sir, whether the Ministry has received several complaints about the present working of the Indian Air-Hnes Corporation, about the immense relays in the services which are being run at present and, if so, what steps are being taken to rectify them?

SHRI N. KANUNGO: Yes. Sir: at the present moment there is dislocation of service because of strikes.

SHRI BIREN ROY: In view of the slogan "work to rule" already raised and adopted by the I.A.C. pilots, and the mishandling of the situation, is the I.A.C. in a position now to operate any new services as has been envisaged?

SHRI N. KANUNGO: Yes. I hope that it will be possible to operate the services on the 1st of October.

SHRI A. D. MANI: In view of the serious difficulties which the I.A.C. has with its pilots, does the Minister think that there is adequate staff for running the new air service?

SHRI N. KANUNGO: Yes, that is what I said: there is a strike on and the matter has been referred to the appropriate tribunal, and I hope that the decision of the tribunal will he available shortly.

SHRI P. K. KUMAR AN: May I know, Sir, whether there has been any demand, or whether there is any proposal to run another service between Hyderabad and Delhi?

SHRI N. KANUNGO: No, Sir.

SHRI SYED AHMAD: May I know,. Sir, whether any representation has been received by the hon. Minister from the Government of Madhya Pradesh to extend the air service to Raipur, Jabalpur and other places of Madhya Pradesh and what action has been taken with regard to these places, not Bhopal only?

SHRI N. KANUNGO: The service will run through alternately between Calcutta, Rourkela, Raipur, Bhopal and Delhi.

SHRI AKBAR ALI KHAN: May I know, Sir, whether the line that will be connected with Visakhapatnam, Bhubaneswar and Calcutta will alar be connected Hyderabad?

SHRI N. KANUNGO: Yes, the service will run from Calcutta to Visa-khapatnam so that it will connect with the service to Hyderabad.

SHRI ARJUN ARORA: May I know, Sir, if the Government is aware of the fact that the pilots and other employees of the Indian Airlines Corporation have found the reference of their dispute to an industrial iribu-nal extremely unsatisfactory; nd a sort of delaying tactics, and in vi;w of this may I also know if the Government will try direct negotiations, which is a better method of settling industrial disputes?

SHRI N. KANUNGO: Negoti itions in the first instance failed; conciliation has also failed. Of course, at any time negotiations can be taken up, but it has got to be under the aegis of the tribunal.

SHRI SYED AHMED: May I know from the hon. Minister whether the Government has at present no nten-tion of extending the air service to Jabalpur?

SHRI N. KANUNGO: No. Sir.

SHRI BHUPESH GUPTA: May I know, Sir, the reason why the negotiations failed, on what ground they failed, and whether in formulating the terms of reference the employees' association, their unions, etc., were consulted by the Government; nd if in that case they made any suggestions?

SHRI N. KANUNGO: The dispute is regarding the limitation of hours of flying, and no agreement could be reached. Therefore the matter had got to be referred to the tribunal.

SHRI P. L. KUREEL URF TALIB: May I know. Sir, whether at present there are any uneconomic services run by the I. A. C, which can be discontinued?

SHRI N. KANUNGO: Most of the routes are uneconomic.

SHRI LOKANATH MISRA: The hon. Minister said that it is proposed to have only flights between Calcutta, Bhubaneswar and Visakhapatnam twice a week. Is it because of want of traffic, or for any other consideration?

SHRI N. KANUNGO: Lack of traffic; this is only a trial in the hope that there will be enough traffic forthcoming.
