MENON: His status is that he has been specially requested by the Committee of Nagas who were very keen on br nging about a peaceful settlement 'vitlun their territory and with the concurrence of the Government of Ind a and the concurrence of the Nagaland Government the Reverend Michael Scott and Shri Jayaprakash Narayan were included in the Peace Mission. I think they have done excellent work. As a result of it we are able to have this truce. The hon. Member objects to the word "truce". I really do not know what other word we can substitute when there have been hostilities between two groups.

DR. ANUP SINGH: Cessation of hostilities.

SHRrMATr LAKSHMI N. MFNON: It is a question of sementics. You can use one word or the other. They have been able to bring about unity. It is really going to solve the problem. It has been difficult of a solution for a long time.

SHRI BHUPESH GUPTA: Nov/, let us not quarrel about the word ";ruce". We have truce in this House also sometimes. Now, the position is I would like to know from the hon. Minister what are the basic principles on which the talks are conducted. We are all interested in a political solution of the problem. May W| have some idea about the basic prtiposals on which the talks are being conducted and which the Government want to promote? In this connection we would like to know whether the Government have received any communication from the Naga prisoners in the Hazaribagh Central Jail expressing their views and resolution with regard to these talks and other things.
