THE MINISTER OF INFORMATION AND BROADCASTING (SHHIMATI INDIRA GANDHI): fa) Government have not taken any decision so far.

PORT HAJ COMMITTEE, BOMBAY

- 84. SHRI SHERKHAN: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (b) if so, what are the reasons for its reconstitutiun: and
- (c) what is the number of members of the Committee and what is their term of office?

THE MINISTER OF EXTERNAL AFFAIRS (SARDAB SWARAN S-INCH): fa) Yes, Sir.

- (b) The Port Haj Committee, Bombay, was constituted under the Port Hai Committee Act, 1932 which envisaged the setting up of three Port Haj Committees one each at Bombay, Calcutta and Karachi. After independence it was considered desirable to revise the 1932 Act to bring it in line with the present requirements. This Act was accordingly repealed by the Haj Committee Act, 1959. The Committee has been constituted as the Haj Committee under the new Act.
- fc) The Haj Committee ha-, 19 members. The terms of office is 3 j'ears.

STATE HAJ COMMITTEES

DISPUTE BETWEEN BANK EMPLOYEES AN» **EMPLOYERS**

- 37. SHRI J. H. JOSHI: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:
- (a) the outcome of the dispute that arose between the bank employees and the employers in the month of August, 1964;
- (b) the number of employees who joined the strike or adopted the policy of go-slow in work; and
- (c) how many banks and their branches were involved in the dis pute?

THE DEPUTY MINISTER IN THE LABOUR MINISTRY OF AND **EMPLOYMENT** (SHRI RATANLAL KISHORILAL MALVIYA): (a) As a result of the tripartite meeting convened by the Chief Labour Commissioner with the representatives of employers employees a settlement was reached on some of the issues on the 18th August 1964. Another settlement on some more issues was arrived at on the 29th August 1964. The parties have agreed to discuss the matter further on the 30th September 1964 with a view to have a long-term settlement. The terms of settlement already

arrived at include payment of ad hoc temporary dearness allowance of 6 percent to clerical staff and 8 per cent to subordinate staff with effect from 1st August 1964, abolition of area IV in respect of 'A' and 'B' class banks affiliated to the Indian Banks' Association with effect from 1st September, 1964 and payment of *ad hoc* increase of Re. 1 in the basic salaries of the subordinate staff of the banks affiliated to the Indian Banks' Association and the Exchange Banks' Association with effect from 1st September, 1964.

- (b) Exact information regarding the number of workers who resorted to "go-slow" is not available.
- (c) Almost all the banks, with the exception of the Reserve Bank of India and the State Bank of India were involved in the dispute.

CEYLON PRIME MINISTER'S VISTX TO INDIA

NON-DELIVERY OF MONEY ORDERS

- 90. SHRI G. MURAHARI: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether Government are aware of a large number of complaints against non-delivery, and delay in de-I livery, of money orders; and
 - (b) if so, what action Government propose to take on those complaints?

THE DEPUTY MINISTER IN THE DEPARTMENT OF COMMUNICATIONS (SHRI B. BHAGAVATI): (a) Yes, Sir. 1 The percentage of such complaints to the total money order traffic is :08 only.

(b) The reasons are loss of M.Os and acknowledgements in transit, inadequate financing and wrong or insufficient addressing and drawing due to fast development of postal facilities involving change of jurisdiction of head and sub-offices. Action has been taken to prevent losses of acknowledgements in transit, to increase the limits of remittances, of cash and the limit up to which postmen and delivery agents are authorised to pay and to publish changes in jurisdiction of Post Offices quickly. High value M.Os are now being transmitted by entry like registered articles.
