Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that Rev. Michael Scott and Shri Jayaprakash Narayan had recently conducted peace talks with hostile Nagas in Nagaland;
- (b) if so, whether they sought prior permission from the Centra! Government for conducting these talks;
- (c) what is the reaction of the Nagaland Government and the hostile Nagas to such talks;
- (d) whether Naga rebel leader Phizo had given any undertaking before the peace talks started; and
- (e) what is the progress so far made in the talks?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI N. MENON): (a) The 'Peace Mission', of which Rev. Michael Scott and Shri Jayaprakash Narayan are members, has been discussing terms for the suspension of operations, with the hostile Nagas.

(to) and (c) The Peace Mission has been contacting the hostile Nagas with the approval of the Government of India and of the Government of Naga-

land. The hostile Nagas were also ready to talk to them.

- (d) No, Sir.
- (e) The Peace Mission has been able to secure an agreement by which there will be suspension of operations with effect from midnight of the 5th 6th September, 1964.

SARDAR SWARAN SINGH: Sir, I may add that this suspension has actually taken place from the midnight of 5th and 6th September.

SHRI A. M. TARIQ: May 1 know what is the *locus standi* of one Mr. J. P. Narayan and Mr. Michael Scott? Is it the policy of the Government of India to recognise every Tom, Dick and Harry for negotiations?

(Interruptions.)

SHRI P. N. SAPRU; It is a serious reflection. I strongly protest against it.

SHRIMATI LAKSHMI N. MENON: That would be expunged.

SHRI A. M. TARIQ: It is my parliamentary right. For me Mr. Michael Scott is neither an Indian nor a Naga. I would like to know what is his *locus standi* in this matter. I would also like to know why the word 'truce' has been used with reference to Naga rebels. The word 'truce' is used when two countries are at war with each other. I would like to know the position of the Government of India in using the word 'truce' between Nagas and the Government of India.

Shrimati Lakshmi N. Menon: Sir, first I refer to the member_s of the Peace Mission about whom, such derogatory remarks were made. They are four persons who are respected very much. About Shri Jayaprakash Narayan I would say I take very strong exception to the language used by the hon. Member.

SHRI A. M. TARIQ: I will wit ldraw it *on one* condition. In reply to a previous question the Minister of External Affairs said that we should not take seriously any individual.

(Interruption.)

DR. GOPAL SINGH: It is an insult.

SHRIMATI LAKSHMI N. MENON: His status is that he has been specially requested by the Committee of Nagas who were very keen on br nging about a peaceful settlement 'vitlun their territory and with the concurrence of the Government of Ind a and the concurrence of the Nagaland Government the Reverend Michael Scott and Shri Jayaprakash Narayan were included in the Peace Mission. I think they have done excellent work. As a result of it we are able to have this truce. The hon. Member objects to the word "truce". I really do not know what other word we can substitute when there have been hostilities between two groups.

DR. ANUP SINGH: Cessation of hostilities.

SHRrMATr LAKSHMI N. MFNON: It is a question of sementics. You can use one word or the other. They have been able to bring about unity. It is really going to solve the problem. It has been difficult of a solution for a long time.

SHRI BHUPESH GUPTA: Nov/, let us not quarrel about the word ";ruce". We have truce in this House also sometimes. Now, the position is I would like to know from the hon. Minister what are the basic principles on which the talks are conducted. We are all interested in a political solution of the problem. May W| have some idea about the basic prtiposals on which the talks are being conducted and which the Government want to promote? In this connection we would like to know whether the Government have received any communication from the Naga prisoners in the Hazaribagh Central Jail expressing their views and resolution with regard to these talks and other things.
