- (a) whether any note was received from the Ceylonese High Commissioner in India about the reparted speech of our High Commission T at Jaffana in Ceylon to the Tamil Association: and
- (b) if so, what action was taken in this regard?

THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): (a) and (b) No note was received but the Ceylonese High Commiss oner verbally conveyed the regret and concerns of the Government of Ceylon about the speech delivered by our High Commissioner in Jaffana on 26th June, 1964.

It was pointed out to the High Commissioner for Ceylon that our High Commissioner's remarks had been played up out of context and should be read in the context of the entire speech. It could not be construed as anything more than the suggestion that the dispute on the language question in Ceylon should be justly settled by the Ceylonese people themselves. The position has been fully understood by the Ceylon Government.
