AEROPLANES MANUFACTURED AT KANPUR

- 99. SHRI RAM SINGH: Will the Minister of DEFENCE be please! to state:
- (a) whether it i_{s a} fact that the Aircraft Manufacturing Depct at Kanpur has so far manufactured only 4 aeroplanes; and
- (b) if so, what steps are proposed to be taken by Aeronautics (India) Ltd., which has now taken over the management of the Aircraft Manufacturing Depot at Kanpur to remove those factors which were responsible for the failure to keep to the production schedule?

THE MINISTER OF DEFENCE PRODUCTION IN THE MINISTRY OF DEFENCE (SHRI A. M-. THOMAS): (a) Yes.

(b) Aeronautics India Limited are examining the production potentialities of their Kanpur Division. The steps which they propose to take to remove the factors which wer(» responsible for the failure to keep to the production schedule will be known only after the examination is conclud-ed.

PAK REFUSAL TO ACCEPT PAKISTANI INFILTRANTS

100. SHRI R. K. BHUWALKA: Will the Minister of External Affairs be pleased to state:

- (a) whether it is a fact that Pakistan has refused to take back a large number of Pakistani national; who have illegally infiltrated into the Indian territory;
- (b) if so, what i_s the number of such infiltrants; and
- (c) what efforts are being m?de by the Government of India to put pressure on Pakistan to accept them?

THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): (a) to (c) Pakistani nationals who have illegally infiltrated into 598 R.S.—5.

India are sent back to Pakistan after being served with Notices under the Foreigners' Act and are not handed over to authorities in Pakistan. The question of Pakistan's refusal to take back such persons, therefore, does noT arise. Pakistan has, however, contended that some Indian Muslims are being thrown out of India by branding them as Pakistani infiltrators. This allegation was categorically denied in course of the Home Ministers' meeting in April last.

NAVAL BASE IN ANDAMAN-NICOBAR ISLANDS

101. SHRI M. RUTHNASWAMY: Will the Minister of Defence be pleased to state whether Government are considering any proposal for the development of a naval base in the Andaman-Nicobar Islands as part of the naval defence of India?

THE MINISTER OF DEFENCE PRODUCTION IN THE MINISTRY OF DEFENCE (SHRI A. M. THOMAS): Yes, Sir. A Naval Base is being developed in the Andamans and Ni-cobar Islands according to a phased programme.
