

**f [HIGHER EDUCATION FOR TRAINEES OF I.T.Is.**

53. SHRI V. M. CHORDIA: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state the arrangement, if any, that exist in the country to give higher technical education to trainees who have passed the Industrial Training Institute's examination?]

The Ministry of Education has also got a scheme to enable those engaged in engineering work to attend part-time courses which lead to a diploma provided they have sufficient general educational background. But, there is no arrangement for the trainees in general to get higher technical education.]

Burma have entered Tirap Frontier Division as refugees.

(b) The Government of India has informed the Government of Burma that these refugees are their Consular charge, that the Government of Burma should pay for their maintenance and that they should be repatriated as soon as possible. The Burmese Ambassador in New Delhi has asked for lists of these refugees which are being prepared and the Burmese Government will be requested to commence repatriation as soon as the lists are handed over.
