THE MINISTER OF STEEL AND MINES (SHRI N. SANJIVA BEDDY): (a) to (c) Yes, Sir. A contract has been entered into under the Indo-U.S.S.R. Trade Plan for 1964 for the import of 100,000 tons of Pig Iron in instalments by the end of 1964. Payment will be made in Indian rupees

Will the Minister of RAILWAYS be pleased t'o state:

(a) whether it is a fact that the Western Railway are planning to dismantle (the Morvi-Tankara and Morvi-Amran Road narrow gauge railway tracks;

(b) if so, whether the volume of traffic on these lines has been ascertained;

(c) whether Government received any representation to the effect to either continue the existing narrow gauge tracks or to install metre gauge tracks; and

(d) if so, the action proposed to be taken on the representation?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAM NATH): (a) and (b) A decision t'o close these two narrow gauge lines from 1st April 1965 was taken in September, 1963 in consultation with the State Government, as the traffic offering was not enough to justify the retention of these two narrow gauge sections.

(c) Representations have been received for their retention and also for their conversion t'o metre gauge.

(d) The entire issue is being reexamined.

**RAILWAY STATION AT GOVTNDPUR ON
