However, it may be necessary to double some more sections on this route during the Fourth Plan, and a<sub>s a</sub> first step it is proposed to carry out a survey for the doubling of the Poona-Dhond section (76 in 1065-66 with a view to undertaking the actual doubling in 1966-67.
