

**COMPLAINT OF CORRUPTION AGAINST
EMPLOYEES AT DELHI STATION**

231 SHRI JAGAT NARAIN Will the Minister of RAILWAYS be pleased to state

(a) whether any Member of Parliament made complaints of corruption against Railway employees of the Commercial Branch at Delhi Station, to the Railway Minister or Deputy Minister in 1962-63 and 1963-64,

(b) if so, the action taken to investigate the complaints and the results arrived at, and

(c) whether the results were conveyed to the Member of Parliament concerned?

**THE MINISTER OF STATE IN THE
MINISTRY OF RAILWAYS (SHRI
RAM SUBHAG SINGH)** (a) Yes (1) In January and April 1963, Shri Jagdev Singh Siddhanti, M P, addressed two letters to the then Minister for Railways alleging corrupt practices on the part of Booking Clerks at Delhi Station

(ii) In February and August 1963, Moulvi Abdul Ghanı Dar, M P, addressed two letters to the then Deputy Minister for Railways containing allegations of corruption against the Parcel Clerks of Delhi Station

(b) Investigations were taken up promptly by the Central Investigation Agency of the Railway Board and the Zonal Railway was asked to take necessary action against the staff held responsible on the basis of investigations. The staff held responsible have since been punished. They and some other suspected clerks have been transferred out of Delhi. Also other measures, viz frequent surprise checks and watch by Vigilance staff, etc, have been introduced to detect malpractices at the counters

(c) In the complaints mentioned in item (i) above, the Member of Parliament concerned was informed of the action taken. Regarding item

(ii), the Member of Parliament concerned was contacted by a staff of Central Investigating Agency to get details of the allegations and necessary action was taken on the basis of the information furnished by him.
