Production has been planned for 100,000 tonnes of Galvanised Corrugated Sheets in the expansion programme of the Rourkela Steel Plant and a further capacity of 210,000 tonnes is envisaged in the first stage of the Bokaro Steel Plant.

RAILWAY LINES BETWEEN SINI JUNCTION AND PANDRASALI

f SHRI SANKAR PRATAP 195. <J SINGH DEV: LSHRI LOKANATH MISRA:

Will the Minister of RAILWAYS be pleased to state whether there is any proposal under Government's consideration to change the route of the proposed new railway line between Sini Junction and Pandrasali on the South Eastern Railway so as to touch Saraikila, the headquarters of the Sub-Division?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAM NATH): No.

CESS CHARGE ON PASSENGER TICKETS ON WESTERN RAILWAY

196. SHRI M. C. SHAH: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that a cess charge of one paisa on passenger tickets is being collected by the Western Railway authorities; and
- (b) if so, the amount of cess realised during the last three years and how it is utilised?

THE DEPUTY MINISTER IN THE MINISTRY OP RAILWAYS (SHRI SHAM NATH): (a) No, Sir.

ALLEGATIONS AGAINST THE OFFICE OF C.C.E.I. CALCUTTA

198. SHRI BHUPESH GUPTA: Will the Minister of COMMERCE be pleas ed to state:

- (a) whether hi_s attention has been drawn to reports published in some Calcutta newspapers in the fourth week of June, 1964 making serious allegations against the Calcutta Office of the Chief Controller of Exports and Imports; and
- (b) whether Government have instituted any inquiry in the light of these allegations into the affairs of that office?

THE MINISTER OF COMMERCE (SHRI MANUBHAI SHAH): (a) Government's attention ha been drawn to reports in some newspapers of the last week of July, 1964 (not June 1964) to this effect.

(b) Detailed enquiries in this case revealed that no licences were issued to bogus firms under the Export Promotion Schemes in 1959.

IMPROPER USE OF NEWSPRINT BY CERTAIN CALCUTTA NEWSPAPERS

- 199. SHRI SANKAR PRATAP SINGH DEV: Will the Minister of COMMERCE be pleased to state;
- (a) whether Government have received any allegations of improper use of newsprint by certain Calcutta daily papers;
- (b) if so, whether any investigation has been made into such allegations; and
- (c) whether Government have any machinery to effectively check up the actual circulation of a newspaper before newsprint quota is sanctioned to it?

THE MINISTER OF COMMERCE (SHRI MANUBHAI SHAH): (a) and (b) Yes, Sir. Investigations have been made into the allegations and final orders are to be passed.

(c) The Government have a machinery under the Registrar of Newspapers of India to check up the actual circulation effectively. On the basis of this check, newsprint quota sanctioned is adjusted, if necessary.

ROPEWAY FOR COAL MINING AREAS

- 200. SHRI SANKAR PRATAP SINGH DEV: Will the Minister of STEEL AND MINES be pleased to state:
- (a) whether Government have decided to construct ropeway for the coalmining areas in order to carry sands etc.; and
- (b) if so, whether any part of the capital cost of the project will be realised from the coalmine owners?

THE MINISTER OF STEEL AND MINES (SHRI N. SANJWA REDDY): *la)* Yes, Sir.

(b) No. The capital cost will be met by the Coal Board from out of its funds.

ATTEMPTED LOOT m AIR-CONDITIONED COACH OF DEHRA DUN-HOWRAH EXPRESS

- 201. SHRI FARIDUL HAQ ANSARI: Will the Minister of RAILWAYS be pleased to state:
- (a) whether an attempt was made by armed men to loot the occupants of an airconditioned coach of 10 Down Dehra Dun-Howrah Express near Seohara Station, in the first week of June, 1964; and
 - (b) if so, what are the details of the case?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAM SUBHAG SINGH): (a) Yes, Sir.

(b) On 5th June 1964, 10 Down Dehradun Express was stopped by someone pulling $th_{\rm e}$ alarm chain just when it started from Seohara railway

station at 00-29 hours. It was reported that 4 miscreants entered the corridor type 1st class coach (and not air-conditioned coach) which was objected to by the coach attendant but they promised to get down at the next halt as the train had already moved. After a short while, the coach attendant heard the miscreants attempting to open a cabin of the coach. The coach attendant[^] questioned the miscreants whereupon they fired one round from a country made pistol, injuring him in his thigh. The miscreants got down after pulling the alarm chain and ran away in the darkness of the night. A case under Section 3071393 I.P.C. has been registered by the Government Railway Police and is under investigation.

ALUMINIUM PLANT IN THE PUBLIC SECTOR
