OIL PRODUCTION IN FOURTH PLAN

(a) the targeted production of oil in the Fourth Five Year Plan; and

(b) the break-up Of consumption of oil in industrial and domestic sectors?

THE MINTSTER OF PETROLEUM AND CHEMICALS (SHRI HUMAYUN KABIR) : (a) The targets of production of oil are 'being formulated in consultation with the Planning Commission.

(b) It is difficult to make a precise calculation. At present roughly 25 per cent, of total consumption may be taken to be in the household sector and the balance in the industrial
