**FAMILIES -OF JAWANS LIVING IN GOV-  
ERNMENT QUARTERS AT LUCKNOW**

364. SHRI BHUPESH GUPTA: Will  
the Minister of DEFENCE be pleased to  
state:

(a) whether the families of tie jawans-. who had been sent to.-the for- ward areas towards the end of 1962 and in early 1963 were allowed to live in the Government quarters at Luck-now and other places free of ,any charge;. ;£•;

(b) if so, whether it is a fact that this arrangement has now been given up and the families have been asked to vacate thē quarters umess they would pay rents at market rates;

(c). whether in this connection the military authorities at Lucknow have 'received any represt ntations from these affected families, and

(d) the" action Government have taken on those representations

THE DEPUTY MINISTER IN THE  
MINISTRY OF DEFENCE . (DR. D. S.  
RAJU): (a) and (b) under the existing rules, families of JCOs .and. ORs posted to operational areas are .permitted to retain family accommodation at the old duty' station only if the accommodation is not' required for incoming "troops. With the arrival of families of relieving troops there was shortage of married accommodation for entitled persons the separated families werē asked to- vacate the quarters failing which they were liable to pay .market rent. Sixty of. such separated families at Lucknow ,are continuing to occupy the accommodation on payment of market rent.

(c) and (d) In view of the difficulties experienced by separated families of JCOs and ORs Government .have sanctioned the hirng of 390 houses for JCOs and 970 houses for ,QRs, at 30 stations including Lucknow. The number of houses to be hireq<sup>l</sup> at each station is determined by the Army Headquarters within the" overall j number sanctioned. Action' is being I taken by the local military authorities to hire accommodation for the separated families within the prescribed limits in all the stations. No accommodation could be hired for the purpose at Lucknow so far.
