THE MINISTER OF HEALTH (DR. SUSHILA NAYAR): There is no proposal at present for undertaking immunisation of entire child population ₀f Delhi against poliomyelitis.

(b) The family planning programme is already integrated with Public Health and Medical Services and this integration i_s being further strengthened.
