JHUGGI-JHOPRI DWELLERS

*224. SHRI B. K. GAIKWAD: Will the Minister of WORKS AND HOUSING be pleased to state:

(a) the number of people living at present in jhuggis and jhopris in Delhi;

(b) the number of jhopris demolished by Government since January, 1964;

(c) whether it is a fact that thousands of such persons were rendered homeless due to the demolition of their jhopris during the recent rainy season;

(d) if so, whether Government have provided them with any alternative accommodation; and

(e) if not, what is the reason thereof?

THE MINISTER OF WORKS AND HOUSING (SHRI B. K. CHAND KHANNA): (a) About 3,50,000 families against the original total of about 65,800 families.

(b) About 5,200 jhopris occupied by 4,800 squatter families were demolished under the Jhuggis and Jhopris Removal Scheme.

(d) and (e). During the current rainy season from the 1st July upto date 791 squatter families were removed from Government land; and

all but 24 were provided with alternative accommodation under the Scheme. The 24 families who were not provided accommodation either made their own arrangements or refused the accommodation offered to them.
