#### STATEMENT

##### *Fertilizer Plant at Kothagudium*

The following progress has been made in the establishment of a fertilizer factory, at Kothagudium:—

1. Foreign collaboration proposals have been approved by the Government of India.

2. Land acquisition proceedings are in progress and the Company expects to obtain possession of the land before commencement of construction which is scheduled for December 1964.

3. Necessary guarantees for the supply of coal, power and water have been obtained.

4. Consent for issue of capital has been obtained from the Controller of Capital Issues.

5. The World Bank and A.I.D. have approved, in principle, the grant of loans for the project.
