

(c) Land has been allotted to or earmarked for allotment to housebuilding co-operative societies which were either dispossessed of their land or in whose favour Government had issued notices under section 4 and/or section 6 of the Land Acquisition Act, 1894, and which had deposited with Government necessary money therefor. In the case of other societies no land is available where municipal services—such as water, sewerage and electricity can be provided within the next five to ten years. However, these societies have been requested to intimate by 31st October, 1964 whether they are interested in the allotment of undeveloped land in such areas (i.e., areas where services cannot be provided). The question of allotment of land to them will be considered on receipt of their replies which are awaited.]

(a) whether it is a fact that some days back Pakistani agents laid mines on the Kargil Road in Srinagar;

(b) if so, the amount of loss that resulted from their explosion; and

(c) the steps taken by Government to prevent recurrence of such activities?]

गृह-कार्य मंत्री (श्री गुलजारीलाल नन्दा):
(क) जी हाँ ।

(ख) कारगिल के समीप बिम्बट नाले पर एक पुल उड़ गया । जम्मू व काश्मीर सरकार की एक गाड़ी कारगिल के समीप पश्क्यूम गांव के पास एक सुरंग से टकराई । इसके फलस्वरूप उस गाड़ी का अगला भाग उड़ गया और उस गाड़ी के चालक और सफाई करने वाले को मामूली चोटें आईं ।

(ग) इस का सम्बन्ध मुख्यतः राज्य सरकार से है । वे स्थिति पर ध्यान दे रहे हैं और ऐसी कार्यवाहियों के पुनः होने से रोकने के लिए आवश्यक कदम उठा रहे हैं ।

[THE MINISTER OF HOME AFFAIRS (SHRI GULZARILAL NANDA): (a) Yes, Sir.

(b) A bridge across Bimbat Nullah near Kargil was blown off. A vehicle of the Jammu and Kashmir Government struck a mine near village Pashkyum near Kargil as a result of which the front portion of the vehicle was blown off and the driver and the cleaner of the vehicle sustained minor injuries.

(c) This is primarily the concern of the State Government. They are watching the situation and are taking necessary steps to prevent recurrence of such activities.]

SETTING UP OF UNIVERSITIES AT KANPUR AND MEERUT

470. SHRI SITARAM JAIPURIA: Will the Minister of EDUCATION be pleased to state-

(a) whether the Government of Uttar Pradesh have recently approached the University Grants Commission for setting up universities at Kanpur and Meerut;

(b) if so, whether the University Grants Commission has given permission for the same; and

(c) when these universities are likely to be set up?

THE MINISTER OF EDUCATION (SHRI M. C. CHAGLA): (a) Not recently, but in 1959 and 1960 the Government of Uttar Pradesh did approach the University Grants Commission for establishing universities at Meerut and Kanpur.

(b) Yes, Sir.

(c) The matter is under the consideration of the Government of Uttar Pradesh.

(a) whether it is a fact that Government received some complaints from Delhi citizens against the Delhi Police in the month of July, 1964; and

(i) In 1 case departmental action is being taken against the official.

(ii) In 11 cases allegations were not substantiated on inquiry.
