#### ALL INDIA EDUCATIONAL SERVICE

486. SHRI R. K. BHUWALKA: Will the Minister of EDUCATION be pleased to state:

(a) the progress so far made in the constitution of the All India Educational Service; and

(b) when the service would be constituted?

THE MINISTER OF EDUCATION (SHRI M. C. CHAGLA): (a) (b) All the State Governments *excepting* Punjab, Madhya Pradesh, Rajasthan and Maharashtra have agreed in principle to participate in the proposed All India Educational Service. Further action to constitute the Service will be taken in the light of the final decision of the aforesaid State Governments.

(a) whether Government have issued a directive that Government employees should not associate themselves with Moral Re-Armament Movement; and

(b) if so, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI L. N. MISHRA): (a) Government have issued no directive imposing a blanket ban on the association of Government servants with the Moral Re-Armament Movement except in their official

capacity. In their private capacity Government servants have only been asked to ensure that in their association with the activities of the Moral Re-armament Movement, they do nothing which may be construed as participation in political activities.

(b) These instructions are in accordance with the Government's general policy in such matters.

#### SCHOOL FOR HIGHER LEARNING IN PAINTING AND SCULPTURE UNDER THE LALIT KALA AKADEMI

488. SHRI I. K. GUJRAL: Will the Minister of EDUCATION be pleased to state:

(a) whether the Lalit Kala Akademi had, some years ago, prepared a scheme for setting up an institution of higher learning in Painting and Sculpture; and

(b) if so the reasons why this scheme has not been finalised so far?

THE MINISTER FOR CULTURAL AFFAIRS IN THE MINISTRY OF EDUCATION (SHRI R. M. HAJARNAVIS): (a) Yes, Sir.

(b) It was not possible to consider the Scheme so far for want of funds. The question will be taken up for consideration if funds are available in the Fourth Five-Year Plan.
