Shri M. C. CHAGLA: If it is true, it is a shocking and a scandalous thing. I have heard such things but I do not know how to check them.

SHKI JAISUKHLAL HATHI: The increase in the sabotage activities has not been during the last one month or so but during the last three or four months.

SHRI I. K. GUJRAL: He has not answered my point.

SHRI A. D. MAN I: Is it a fact that these bomb cases have become frequent on account of the Government of Jammu and Kashmir and the Government of India tolerating without let or hindrance the secessionist propaganda in Kashmir?

SHRI JAISUKHLAL HATHI: I think both are independent subjects. The explosion of bombs is an act done by certain miscreants, spies, agents, those who want to create a certain atmosphere in the country.

SHRI G. M. MIR: I would like to know whether it is a fact that these bomb explosions have been going on in Jarnmu and Kashmir for the last, say, ten to fifteen years and not even a single case has been traced out, and whether it is also a fact that these bomb cases usually occur in the Poonch sector and Mendhar sector, which are just near the border, and we have a large number of troops s'ationed over there. May I know, Sir, whether the Government are going to make certain arrangemets to thwart these bomb explosions because the people of the Poonch sector and Mendhar sector are feeling great harassment because of these explosions? I would request the Central Government . . .

MR. CHAIRMAN: No request.

SHRI G. M. MIR: I would like to know whether the Central Government will take some special care to see that these bomb explosions, which seem to be organised and aimed at strategic points, which have been occurring just near the pipe-line of the power house, and also the Deputy Commissi oner's office, just near the brigade headquarter and in the city, are stopped, whether they have taken any action and whether any person has been arrested in this regard.

MR. CHAIRMAN: I hope there is no other 'whether'.

SHRI JAISUKHLAL HATHI; These bomb explosion cases have really started from 1957. In some years the number has decreased very much; in recent years they have increased, and we have taken all possible care along with the Jarnmu and Kashmir Government to see that these activities are stopped.

CAPITATION FEES IN TECHNICAL Institutions

•416. SHRI N. SRI RAMA REDDY: Will the Minister of EDUCATION be pleased to state whether it is a fact that he made a sta.ement in Bangalore in July, 1964 that the system of levy of capitation fees in certain private Technical institutions is as good as black market?

THE MINISTER OF EDUCATION (SHRI M. C. CHAGLA): Yes, Sir. The correct expression was "blackmarket-ing in education".

SHRI N. SRI RAMA REDDY: If this is the impression of the hon. Minister I would like to know what prevents him from taking action to see that such a thing does not take place, especially in these technical institutions.

SHR M. C. CHAGLA: Sir, I have taken every possible action. The understanding was that private engineering institutions should not be started without the consent of the All-India Council in Delhi. The Mysore Government affiliated these colleges although our sanction was not taken. We have now appointed a committee of the University Commission to go and find out whether standards are being maintained or not. Their report has just been made and we are considering it.

SHRI N. SRI RAMA REDDY: I would like to know whether it is not taking place as a normal practice in the country, in starting these technical institutions, that huge amounts have been collected in the name of capitation fees without let or hindrance. I would like to know whether concrete steps are going to be taken to stop this kind of collection of heavy capitation fees.

Shri M. C. CHAGLA: There is blackmarketing in many departments, but I think the most scandalous black-marketing is in education. I am conscious of the evil; I am trying to fight it and I am trying to stop it altoge-
