**HUNGER STRIKE BY THE LEADERS OF TEL SHODHAK MAZDOOR UNION, BARAUNI**

638. SHRI P. K. KUMARAN: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

(a) whether there was any hunger strike by the leaders of the Tell Shodhak Mazdoor Union, Barauni, in the first week of August, 1964;

(b) if so, what were the reasons for the hunger strike;

(c) whether the dispute has now been settled; and

(d) if not, what are the reasons for the delay?

THE MINISTER, OF PETROLEUM AND CHEMICALS (SHRI HUMAYUN KABIR): (a) Yes, Sir.

(b) The reasons stated we'e (i) retrenchment of workers on account of the completion of the first phase of refinery works, (ii) payment of weekly rest for the period prior to 10th December, 1962 and (iii) reduction of rent for the operation^ staff sharing accommodation in the Township.

(c) and (d) While the disputes relating to (") and (in) above have been settled, the retrenchment of construction workers rendered surplus is inescapable.

grant basis for Secondary Schools during the Third Plan period; and

(b) if so, what are those schemes for which Central funds would be earmarked?

THE MINISTER OF EDUCATION (SHRI M. C. CHAGLA): (a) Yes, Sir.

In addition to the schemes approved earlier, a new scheme has been sanctioned this year.

(b) The Scheme is 'Improvement of Secondary Education' which has the following components: —

- (1) Strengthening of Science Laboratories;
- (2) Special Training of Science Teachers;
- (3) Improvement of School Libraries.

(a) whether it is a fact that an illegal arms factory was detected in Jabalpur in March, 1964;

(b) if so, what action has been taken by the Government; and

(c) how many persons were arrested in this connection?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI JAISUKHLAL HATHI): No, Sir.

(b) and (c) Do not arise.

**CONSTRUCTION OF YOUTH HOSTELS IN INDIA**

641. SHRI G. M. MIR: Will the Minister of EDUCATION be pleased to state:

(a) whether it is a fact that Youth Hostels Association in India has decided to build hostels in major cities before the end of the Third Plan; and

(b) if so, how much amount has been earmarked for this purpose?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION (SHRI BHAKT DARSHAN): (a) The Youth Hostels are proposed to be built in major cities and in other parts of the country by the Government of India and not by the Youth Hostels Association of India. The scheme is, however, yet to be approved by Ministry of Finance.

(b) Subject to the approval of the scheme, the total amount available is about Rs. 18-15 lakhs.

ALAGE-SAN) : The Ammonia plant in the Fertilizer factory is expected to start trial operations in November followed by the urea plant in about 6 weeks' time thereafter. The expenditure incurred up to 31st July 1964 is Rs. 27-928 crores.]
