### COTTON CULTIVATION IN RAJASTHAN

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI SHAH NAWAZ KHAN): (a) Yes.

(b) The total area sown under cotton during 1961-62 was 1'6 per cent of the gross cropped area. This percentage can be expected to go up after perennial irrigation from Rajas-than Canal becomes available.

# FARRAKHA BRIDGE

669. Shri SITARAM JAIPURIA: Will the Minister of TRANSPORT be pleased to state what is the progress made so far in the execution pro gramme for the Farrakha Bridge?

THE DEPUTY MINISTER IN THE MINISTRY OF TRANSPORT (SHRI AHMED MOHIUDDIN): The construction of the Farrakha Bridge, being a part of a larger project of the construction of the Barrage, its progress is tied up with the progress of the main project. The Farrakha Barrage project is expected to be completed lty 1S7S.

#### HALDIA PORT

- 670. SHRI SITARAM JAIPURIA: Will the Minister of TRANSPORT be pleased to state:
- (a) whether it is a fact that Government have not abandoned the project of constructing the Haldia Port; and
- (to) if so, what are the proposals for the execution plan for the said port?

THE MINISTER OF TRANSPORT (SHRI RAJ BAHADUR): (a) and (b) The Government of India have never entertained any intention of abandoning the Haldia Dock project. On the other hand, they have been pursuing the project vigorously.

A Master Plan of the project has been by the Commissioners consultation with experts from the Port of London Authority and the Commissioners' Consulting Engineers, M/s Rendel, Palmer & Tritton, London. Considerable progress has also been made on the detailed planning of the various facilities intended to be provided at Haldia, The preparation of the designs, drawings and specifications is in progress. Land acquisition required for the project according to the Master Plan is in progress. So far, 4:4 square miles of land have been acquired. The land required for the rail link has been acquired and handed over to the South Eastern Railway by the West Bengal Government. The detailed planning and designs of the stations in this link have been completed. The work has already been taken up. As regards the road link to Haldia, the existing road between Panchkura and Haldia, which is to be used for the transport of construction materials, is being suitably strengthened and widened by the West Bengal Government who have also taken up the work of the Tamluk by-pass road to relieve the traffic congestion in the area.
