The purpose of the Farm Leaders Exchange Programme is main y to help Indian Farmers discover techniques, which can be adopted to India's small farm holdings and to build up friendship and understasding between the farmers of the two countries. Under this programme, 5 groups of Americans farmers totalling 68 visited India during 1960, 1961, 1962, 1963 and 1964. Only two groups of Indian

-farmers, aggregating 22, visited the U.S.A. in 1961 and 1962. Due to the 'Emergency' Indian farmers were not :sent to the U.S.A. in 1963.]

ESTABLISHMENT OF SUGAR FACTORY AT PARLAKHEMUNDI (ORISSA)

675. SHRI N. PATRA: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) whether any officer of the Agricultural Department of the Gov ernment of India visited recently Parlakhemundi in the State of Orissa along with some other officers of the State Government to investigate about the feasibility ₀f establishment of a sugar factory at that place; and

(b) if the answer to part (a) above be in the affirmative, whether any report has been submitted by the concerned officer and if so what are its contents?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI D. R. CHAVAN): (a) and (b) A study team of three Central Government officers, while visiting certain site_s in Orissa State selected for on-the-spot studies in connection with applications for establishment of new sugar factories passed through Parlakhemundi. The State officials accompanying the team showed some cane fields to the Central Government Officers in Parlakhemundi areas. As no application for setting up a sugar factory at this place has been received, the question of any action or re- . port does not arise.
