CENTRAL ROAD BOARD

677 SHRI M. C. SHAH: Will the Minister of TRANSPORT be pleased to state whether there is any proposal under the consideration of Government to set up a Central Road Board?

THE MINISTER OF TRANSPORT (SHRI RAJ BAHADUR): The question of setting up a Central Road Board has been under consideration for some time past. The State Governments were also consulted in the matter. Generally, they are not in favour of any Central Body being constituted with executive powers in regard to functions that fall within the purview of the State Governments. The matter was also discussed recently at the fifth meeting of the Transport Development Council held at Srinaga_T from the 23rd to 25th July 1964. The Government of

India are now considering the question of constituting a Central Road Board covering only the sphere of responsibility of the Central Government.

TOTAL AREA OF LANDS ACQUIRED FOR THE MANGALORE HARBOUR PROJECT

678. SHRI P K. KUMARAN: Will the Minister of TRANSPORT be pleased to state:

(a) what is the total area of lands o far acquired for the Mangalore Harbour Project;

(b) whether there is any proposal for acquiring further acreage of land for this harbour project:

(c) whether the feasibility of acquiring lands in the alternate locality suggested by the Panambour-Baikampady Grama Rakshana Samithi has been examined by Government; and

(d) what steps Government have taken to rehabilitate those villagers who were displaced or are being displaced from their rich cultivable lands which were already acquired by Government?

THE MINISTER OF TRANSPORT (SHRI RAJ BAHADUR). (a) and (b) It is proposed to acquire an area of 1207.53 acres of land for the immediate requirements of Mangalore Harbour Project. This area has already been notified for acquisition under the Land Acquisition Act. Out of this an area of 43.18 acres of land has been formally acquired. In addition, an area of 463.08 acres has also to the Project been handed over authorities although legal formalities in respect of this area have yet to be completed.

It is also proposed to freeze land values in an additional area of 1500 acres which may be required for the future development of the Harbour Project.
