corruption practices in this Commission and that thereafter the Khadi Commission thought it proper to get itself transferred to the other Ministry?

SHRI LAL BAHADUR: It is absolutely wrong, Sir. It has no basis at all.

SHRI BHUPESH GUPTA: We would like to know the function of the Khadi Commission especially of its Chairman. May I know whether the function of the Chairman includes his trip to Kerala and other places in order to interfere in the political affairs of the parties and so on, organise the Congress Party, etc.? If it is not so, then may I know whether special permission has been obtained by him from Government? If it is, then we would like to know how exactly this arrangement is made | within the compass of this Commis- i sion.

SHRI LAL BAHADUR: Sir, this is not directly related to this question but why should Shri Bhupesh Gupta deprive the Chairman of the Khadi Commission his chance of visiting Kerala where a large number of Communists are there? It is better that he goes and sees in what way he can be helpful to the Communists.

SHRI BHUPESH GUPTA: I am grateful to the hon. Prime Minister.

SHRI A. D. MANI: Since the export of handloom fabrics and handicrafts has been considerable during recent I years, did Government consult the Ministry of Commerce about the transfer of the Commission to the Department of Social Security? If the Ministry of Commerce was consulted, what wag the opinion of the Ministry of Commerce on the subject?

SHRI LAL BAHADUR: In that case, the hon. Member will have to ask me whether I consulted about half a 'dozen departments, Education, Health, etc. A number of departments were concerned and I should have consulted each and every one of" them. 1 must admit I have not done it but may I say that it is entirely in the discretion of the Prime Minister to do this work and carry on the administration?

SHRI DEOKINANDAN NARAYAN: It is not a fact that the production programme of the Khadi and Gramodyog Commission forms part of the whole cloth industry?

SHRI LAL BAHADUR: Of course, I am prepared to look into what the hon. Member has said because a letter has been addressed to me by the Chairman of the Khadi Commission. Yet, I do not think that the work of khadi and village industries is going to suffer if this subject remains in the Department of Social Security
