

**Commercial production of oil in Barmer Basin**

3284. SHRI RAMDAS AGARWAL: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether the Central Government recently gave its go-ahead to Cairn for executing its Field Development Plan (FDP) in the highly prospective Rajasthan basin (block RJ-ON-91/1) so as to enable the company to initiate work on Rs. 3,800 crore plan for Mangala, Aishwariya, Saraswati and Raageshwari fields in the Barmer districts;

(b) what is the likely Production of Oil Per Day (POPD) and in million metric standards cubic feet per day (MMSCFD) of natural gas indicating how this natural gas will be used; and

(c) by when, Cairn energy, will start commercial production of oil in Barmer Basin?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI DINSHAJ. PATEL): (a) In the block RJ-On-90/1 (not the block RJ-ON-91/1) located in the Barmer district of Rajasthan, Cairn Energy India Pty. Ltd., the operator, has submitted Field Development Plan (FDP) in respect of four commercial discoveries namely Mangala, Aishwariya, Saraswati and Raageshwari. The FDP is yet to be approved.

(b) The FDP submitted by the operator envisages peak oil production @ approximately 112,000 Barrels per day and gas production at approximately 19 MMSCFD. The gas produced would be consumed for internal use.

(c) The commercial production from Barmer basin is likely to start by late 2008.

**GAIL'S MoU with Chinese firms**

3285. SHRI B.J. PANDA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether it is a fact that GAIL has signed MoUs with three Chinese firms;

(b) if so, the details thereof; and

(c) how far will this cooperation help to bridge the gap in oil gas sector in India?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI DINSHAJ. PATEL): (a) to (c) Yes, Sir. During the visit of the Indian delegation led by the then Minister (P&NG) to Beijing,

China on 12-13 January, 2006, GAIL signed Memorandum of Understanding (MoU) with three companies in China, namely, China Petrochemical Corporation (Sinopec), CNOOC International Limited (subsidiary of China National Offshore Oil Corporation) and Beijing Gas Group Company Limited (Beijing Gas).

The MoU mainly focus on cooperation in the areas of Exploration and Production (E&P), Liquefied Natural Gas (LNG) Sourcing, Piped Natural Gas (PNG) & Compressed Natural Gas (CNG), City Gas use for Heating & Cooling, Research & Development (R&D), Training and other gas sector projects of mutual interest.

Through the MoUs signed with Sinopec and CNOOC, GAIL will jointly explore international E&P opportunities, LNG sourcing, participation in LNG projects, etc. with these Chinese National Companies. GAIL and Beijing Gas would cooperate and jointly participate in CNG and PNG projects.

#### **Subsidy on LPG cylinder**

3286. DR. NARAYAN SINGH MANAKLAO: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the domestic LPG cylinders have been subsidised;
- (b) if so, the details of subsidies and the rationale behind this;
- (c) whether the number of LPG connections has been increased over the years;
- (d) if so, the details thereof during the last three years, rural and urban area-wise;
- (e) whether increase of LPG users means higher subsidies; and
- (f) if so, the alternatives to deal with the situation?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI DINSHA J. PATEL): (a) Yes, Sir.

(b) LPG being clean and environment friendly fuel, the Government has tried to promote its consumption. Hence the retail selling prices of domestic LPG have not been revised in line with the international prices.
