on scientihe research m India is meagre as compared to such advanced countries as U.K., U.S.A. and U.S.S.R., and Industry as such do not support research to the extent as is prevalent in some of the advanced industrial countries. Research facilities by way of costly and specialised equipment are also not available in India on a scale comparable with the above-mentioned countries and an inference can therefore be drawn that some Indian scientists working abroad on problems requiring the use of highly specialised equipment and apparatus find it difficult to return to India.]

 - I. (i) To provide office space, office equipment, stenographic assistance postage for official communication and rental for telephones etc.
 - (ii) Suitable furnished living accommodation not exceeding Rs. 25 a day.
 - (iii) Internal transportation on duty by A.C.C. or Air,
 - (iv) While on tour, a daily allowance as admissible to first grade officers.

- (v) Medical facilities to him and his family as admissible to first grade officers.
- (vi) Payment of Customs Duty On household and professional effects and supplies.
- II. Salary and other allowances and cost of international travel and transportation of household effect to India and return.

Expenditure for items under (I) above is borne by the Council of Scientific and Industrial Research, whereas expenditure under (II) above is borne by the U.K. Government.
